

RESOLUTION NO. 2022-0912

A resolution expressing the property taxation policy of USD 347 Kinsley-Offerle with respect to exceeding the Revenue Neutral Tax Rate for financing the annual budget for 2022-2023.

Whereas, 2022 HB 2239 amending K.S.A 79-2988, provides that a levy of property taxes to finance the 2022-2023 budget of USD 347 exceeds the Revenue Neutral Tax Rate to finance the 2022-2023 budget of USD 347, be authorized by a resolution.

NOW, THEREFORE, BE IT RESOLVED by USD 347 that the 2022-2023 budget with a levy of property taxes exceeding the Revenue Neutral Tax Rates calculated for 2022-2023, as adjusted pursuant to 2022 HB 2239 amending K.S.A 79-2988 is hereby adopted.
